2B. Project Description

1. Provide a description that addresses the entire scope of the proposed project and how the Collaborative Applicant will use grant funds to comply with 24 CFR 578.7:

The CoC is a countywide partnership of over 250 nonprofit service providers, County departments, developers, elected officials, faith-based organizations, youth, law enforcement, schools/universities and other interested parties committed to finding homes for individuals and families experiencing homelessness. The Collaborative Applicant (CA) is the Department of Housing, Homelessness Prevention and Workforce Solutions which will support the CoC Board of Governance (BOG) and CoC standing committees to carry-out the following activities that will expand and enhance a countywide response to ending homelessness: 1) be responsive to the strengths and gaps identified in the Performance Assessment and Gaps Analysis conducted in 2021; 2) implement the Homeless Action Plan which provides actionable strategies such as strengthening system to better prevent and end homelessness, equitably address the health, safety and service needs of people experiencing unsheltered homelessness, expand communities capacity to provide safe and effective sheltering and interim housing, expand and ensure equitable access to permanent housing in our communities, and prevent people from experiencing the crisis of homelessness; 3) initiate the implementation of the Homelessness and Supportive Housing response system; 4) plan and conduct, a point-in-time count for sheltered/unsheltered homeless persons; 5) integrate equity as a core component and shape system-wide priorities tailored to people experiencing homelessness; 6) fully implement and operationalize CES into HMIS to allow for housing connections to be directly facilitated through the system which will further increase efficiency and management of a client's progress towards permanent housing.

The planning grant provides staff that supports and coordinates all aspects of the BOG, CoC, and the subcommittees. These positions will continue to work with CoC leadership, committees and stakeholders to: fulfill the CoC's mission, vision and values, streamline the CoC structure, use data effectively, build capacity for CoC operations and among providers, strengthen CoC's ability to compete for new funding in the CoC NOFO by working to increase capacity throughout the continuum and leveraging all means of funding; improve CoC's ability to evaluate outcomes of both CoC program-funded and ESG-funded projects, including utilizing system-wide project-based performance measures; review and update the written standards, policies and procedures, and provide regular monitoring and technical assistance to help CoC agencies improve performance. Staff will also continue to support and carry-out the goals of the Youth Action Board and the Youth Advisory Committee to end homelessness among unaccompanied and transitional age youth.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

From July 1, 2022 to June 30, 2023, planning grant staff will work with the CoC leadership and the CoC committees to implement the recommendations in the Homeless Action Plan and initiate the implementation of the Homelessness and Supportive Housing response system in Riverside County to make it possible to end homelessness within the next 5 years. Planning staff will continue to prepare staff reports to maintain communication and highlight milestones. Staff will generate progress reports focusing on program goals and outcomes and performance measures to identify trends & areas for improvement. Progress reports will be presented at CoC membership meetings (held 10 times a year) and the Board of Governance (BOG) meetings (held 5 times annually). Staff will also continue to work with the CES Oversight Committee to update and refine written processes and procedures approved by the CoC and BoG. This oversight ensures the policies/procedures comply with Coordinated Entry Notice CPD-17-01. Staff will utilize metrics and analysis that capture progress based on SPM.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

The CoC, in consultation with recipients of ESG program funds within the geographic area, will: 1) Establish and consistently follow written standards. These written standards have been developed by ESG grantees within Riverside County, including HHPWS, the Cities of Riverside Moreno Valley, and Continuum of Care (CoC) membership. This collaboration allows for input on the standards and implementation process developed by organizations that directly provide homeless and housing services, Rapid Re-housing (R/R), and Homelessness Prevention (HP). The ESG Written Standards are approved by the CoC, the County, and City ESG recipients. Thee written standards are reviewed and revised annually, or as needed, to continue to build upon and refine this document; 2) Establish performance targets appropriate for population and program type. Planning staff will ensure HMIS data quality by continuing to develop and work with newly implemented Clarity which has further digitized the HMIS system to provide automated data quality and project outcomes reports. Staff will continue to work with the CoC, HMIS Council, HMIS Lead and Standing Committees to improve the ability of the CoC to evaluate the System Performance Measures (SPM) as defined by the HEARTH Act by increasing the capacity of the HMIS system to evaluate the outcomes of CoC projects, including ESG funded projects. Planning staff will continue to develop tools, processes, and procedures for evaluating system-level performance and enhance the CoC's ability to measure progress towards achieving our goals of ending homelessness in Riverside County; and 3) Monitor recipient and subrecipient performance. Staff will continue to conduct comprehensive monitoring of CoC and ESG projects to: a) ensure that ESG funds are used effectively to assist homeless individuals and families and that the basic ESG program goals are met; b) ensure compliance with ESG regulations and program requirements in the usage of funds and in carrying out program activities; and c) enhance and develop the management capacity of grantees or recipients.
