We don't fund this as a CoC project, but it is part of our continuum of care. We did get HHAP funds toward the operations, but we are lacking in Supportive Services. But, again, it is not a voucher program and we don't place through CES since we only house for 90 days while we try to get people into treatment or next step toward self-sufficiency. Would services at this facility count/qualify?	The only components that will be funded in the FY 2021 CoC Program Competition are: 1. PH (PSH and RRH); 2. TH; 3. SSO; and 4. HMIS. Additionally, Collaborative Applicants may apply for projects that include the TH and PH-RRH component in a single project, a Joint TH and PH-RRH component project. A project proposal to provide supportive services to support a 90-day bridge housing projects would not be eligible under any of the mentioned component types.

Rapid Rehousing may provide supportive services for short-term (up to 3 months) and/or medium-term (for 3 to 24 months) tenant-based rental assistance. Organizations submitting proposals must work with Riverside County CoC staff for CoC Staff to complete the new project applications in HUD E-snaps system prior to October 12, 2021. Applications of selected proposals approved by the Riverside County CoC Board of Governance will be submitted as part of the Riverside County CoC's application for the FY2021 CoC Program Competition. Registering the project with HUD E-snaps does not imply an intent to award, award, or guarantee a contract with the County of any kind.

HUD specifies that PH-RRH and joint TH and PH-RRH projects applications under DV Bonus are for at least \$50,000 per project application. There is no minimum budget amount requirement under CoC Bonus and other project types under DV Bonus.

CoC will include all new projects that pass threshold review, evaluation, ranking and Riverside County CoC Board of Governance approval in its application to HUD except that HUD limits to one (1) Supportive Services Only - Coordinated Entry (SSO-CE) project application per CoC. CES lead agency is the only entity that can apply for SSO-CE project application.
9/16/2021	All	What is the term of the grant?	Proposals selected and approved by Riverside County CoC Board of Governance will be submitted to the U.S. Department of Housing and Urban Development (HUD) as

			part of the Riverside County CoC's application for the FY2021 CoC Program Competition. Once awarded by HUD, the new projects will be funded for a 12-month operation with the earliest possible start date of 2/1/2022. HUD understands that new projects may need additional time for new project preparation and ramp up and would allow the new projects
			to have up to a grant term up to 18 months to spend the 12-month funding. All projects award through the FY2021 CoC Program Competition must end by 12/31/2023.
